



There is [however] a book called *Die Juden und der Weltkrieg (The Jews and the World War)*, which was written in 1916 by a German named **Felix A. Theilhaber** [not by Zeigler], who served as a doctor in the German army during World War I.

Theilhaber also wrote *Jüdische Flieger im Kriege* (Jewish Flyers in the War) in 1918, in which he gave accounts of over one hundred Jewish soldiers who flew for Germany. **Theilhader writings were in the defense of Jews**, to counter accusations that Jews had been a traitorous element in Germany during World War I.

Theilhader was the founder and chairman of *Gesex* (The Society of Sexual Reform). For his involvement with this group, he and fifty other physicians were arrested by the Gestapo in May 1933. After his release two months later, **he emigrated to Palestine, where he co-founded the** *Maccabi Health Care Service*. **He died in 1956 in Tel Aviv**. Links - source - source
