# Nazi Jailed At Judas Trial

A delegation of Nazis appeared as observers at the first hearing of Judas Patler, and watched quietly as he was led before Arlington County Judge Embry by a small army of police and special guards.

nowever, the sight of Judas Patler, striding arrogantly into the court room while surrounded by his guards, was too much for one Nazi. Eric Wenberg, visiting the United States on special assignment from the Australian National Socialist Party, lunged from his seat, tears filling his eyes, shouting, "Patler, you filthy assassin! You rotten swine!" Before Wenberg could reach Patler, however, he was jumped and wrestled to the floor by dozens of police.

At the same time, Patler's knees buckled and he hung limply in the arms of police as he was rushed from the room. He had obviously fainted, his arrogance of moments before completely vanished.

As Wenberg was carried from the room, still struggling with police, he cried: "Long live the American Nazi Party! Long live Matt Koehl!"

Wenberg was later charged with "contempt" of continued on page 6



On August 25, 1967 the White Race lost its greatest leader. Commander George Lincoln Rockwell was shot to death as he was leaving a shopping center, directly across from ANP National Headquarters in Arlington, Virginia.

His assassin had stationed himself atop the roof of a nearby barbershop and, as the Commander was backing his car from the parking lot, he opened fire. Two shots were fired from cowardly ambush. One bullet struck the Commander and killed him instantly.

Moments later John Patler was arrested by Arlington
police just blocks away from
the scene and charged with
the assassination. Several
witnesses saw the Commander's assassin and gave police
descriptions which matched
Patler's. Patler was expelled
from the Party earlier this
year because of his growing
Marxist leanings.

As Jesus Christ had his Judas, so the Commander had Judas Patler. And as Christ has left his mark on history, so has Commander Rockwell.

# Army Denies Burial Right

Commander Rockwell, a veteran of both the Second World War and the Korean War was denied the right to be buried in a national cemetery. He had been decorated on nine occasions, commanded three naval squadrons, had served his country with distinction for nearly 20 years until his honorable discharge from the Navy in 1960. But because he was not a Republican or a Democrat, and because he believed in his be-

loved White Race, he was denied the right to a proper burial by the political hacks and Jew stooges in the Pentagon.

Acting with absolutely no legal basis, the Army denied the Commander the funeral he would have desired. Yet the Star of David, an alien symbol in this Christian country, is permitted in all cemeteries.

#### THE SPIRIT OF LINCOLN ROCKWELL

Friday, August 25, 1967. This date will go down forever as BLACK FRIDAY in the history of our race. When Commander George Lincoln Rockwell was struck down by the bullet of that cowardly assassin, not only did the National Socialist movement lose a leader; the White Race lost its greatest living champion.

Unlike all the sell-out politicians, Commander Rockwell was one man who

Throughout the afternoon in Culpeper, Nazis confronted the U.S. Army at the cemeery gates. Armed military police, flown in by helicopter to disrupt the funeral, barred passage of the funeral cortege until closing time, when the mourners were forcefully turned away.

#### **Body Returned**

was returned to an Arlington funeral home while Party officials met to decide the next course of action. When reliable information had been received that certain groups were planning to seize and desecrate the Commander's remains, Party officials were forced to move quickly to prevent such an attempt.

#### Private Cometery Considered

During the long night following the battle of wills at Culpeper, Party officials attempted to acquire a burial site in local civilian cemeteries and to make other funeral arrangements. They were refused in over a half dozen attempts.

## New Hope! Spotsylvania Site

Finally, after hours of consultation, the Party decided to bury the Commander on its own five-acre tract of land in Spotsylvania County, Vir-1 ginia. A local funeral director offered to make the necessary preparations. Many persons in Spotsylvania bury their loved ones on their own property with no objections from government officials. However, it was learned that certain groups, presumably the Jewish War Veterans, would move to have an injunction placed against a decent burial. Spotsylvania was then ruled out.

Further conferences followed amid threats from Arlington County officials to seize the Commander's remains. Other individuals were also moving to take the body and deny it a decent burial. Party officers had to move fast.

#### Cremation

After all other means had failed, the only alternative left was cremation. The Commander wanted above all else to be accorded proper Party ceremonies in the event of his death.

Later that day, the Commander's remains were returned to Arlington headquarters. A simple, but moving service was conducted by Major Koehl before a group of loyal National Socialists representing America, Canada and points overseas. The press and general public were barred.



# Procession Begins

The procession began to enter Culpeper National Cemetery, uniformed guards by its side, unaware that the helicopters flying above were bringing U.S. troops to halt burial ceremonies. Just moments behind were more than sixty carloads of mourners, also unaware of the day-long standoff that was being planned by the top brass in the Pentagon.

had the guts and integrity to tell the straight, unvarnished truth, regardless of any consequences. He wasn't afraid to say what every decent White man feels in his heart, or to stand up for what he knew was right. As a result, he became the most hated man in America—hated by the Jews and racial traitors who are selling the White Man out to Communism and Black revolution.

George Lincoln Rockwell was born in Bloomington, Illinois on March 9, 1918. His ancestors were English, Scottish, French and German,

and included many Revolutionary War figures. His father was a very famous vaudeville comedian from 1912 until about 1935.

As a youth, Lincoln Rock-well spent most of his time in Boothbay Harbor, Maine, although he also lived in California, New York and New Jersey. Later he entered Brown University in Providence, Rhode Island, where he majored in philosophy. It was here that he first became familiar with the poisonous Liberal and Marxist ideologies.

Rockwell left Brown during the middle of his junior year to fight A dolf Hitler, whom he believed was out to destroy America--as he and millions of other gentile Americans had been told. He joined the Navy as a Seaman, and soon became a fighter pilot. Eventually he rose to the rank of full Commander, leading three naval squadrons in action in both the Atlantic and the Pacific, winning nine decorations.

After the war, Rockwell attended Pratt Institute Art School in New York City, working part-time in advertising and commercial art. In 1948, while still at Pratt, he won first prize in the National Society of Illustrators' competition for a full-page newspaper ad for the American Cancer Society.

A short time later, while serving as commanding officer of a naval reserve squadron in Washington, D. C., Rockwell launched a new magazine, "U. S. Lady", for the wives of American servicemen. In 1949, he founded the first big national advertising agency in the State of Maine.

Recalled to active duty during the Korean War, Commander Rockwell trained Marine and Navy pilots in close air support of ground troops. Afterwards he was transfered to Iceland, where he commanded a squadron at Keflavik.

At about this time, Rockwell became deeply concerned about the way all he had supposedly fought for in two wars

was being turned over to the Communists. He noticed that almost all of the convicted Communist spies and traitors. were persons with names like Rosenberg, Silvermaster, Weiss, Soblen, Sobell, Rose, Greenglass, Gold, Moskowitz and Cohen, etc. He further noticed the high percentage of racial Jews in the leadership of the Communist movement in this country. He was especially shocked to find that Who's Who in Jewry proudly listed many of these atheist Communists as Jews, even though he had believed the Jews were just a religion.

Observing that Adolf Hitler had said that Communism was Jewish, and that the Jews were a menace to every White nation, Rockwell bought a copy of Mein Kampf and read it. He was a mazed to discover the author's remarkable insight into the problems facing the White Man, as well as his plan for saving the White Race and Western Civilization.

For several years Rockwell tried to work with different "Right-Wing" organic
zations, which considered
necessary to "disguise" one
belief in Adolf Hitler and National Socialism. But he finally became disgusted ith
the shallow hypocrisy of these
cowardly Conservatives, and
decided to attack. Raising
the Swastika banner of the
White Race, he declared:

"Since our cause is fundamentally the truth, I do not see how we can win by lying or misrepresenting what we are, for fear of the Jews. The only time in the hundred years of the rise of Communism that this plague has ever been actually beaten, it was beaten not by 'Conservatives', but by radicals and fighters whom the enemy calls 'Nazis'."

Commander Rockwell hung up a Swastika banner in front of his home and dared the Jews to do something about it. They came shortly in droves and mobs, with their friends and dupes, to "do something about it". But Rockwell survived all the rocks, bombs and other Jewish "arguments". The publicity gave him a much-needed national platform. He was now able to call the attention of his fellow Americans to the increasingly critical condition of America and the White Race.

Speaking at great public rallies and before smaller private gatherings, Commander Rockwell won his way into the hearts of millions with his great, revolutionary vision of an all-White America. He introduced the idea of White Power to our people, and reminded them over and over again of the need to fight for the future of their race.

If the true measure of the greatness of a man is the service he renders his fellow men, then Lincoln Rockwell certainly ranks a mong the greatest men of all time. For service was the theme of his entire life. Throughout all the years of his manhood he served first his country, and then his race.

George Lincoln Rockwell sacrificed more and fought harder for the things he held dear--his native land, his fellow countrymen, and, above all, his race--than any man now living. He saw his duty and unflinchingly did it, despite all opposition.

And here we must stop to consider how shabbily, how shamefully the government acted when it saw fit to deny this man the simple right of a veteran to burial, although he had faithfully served his country for so many years. There are few examples in history of such low, mean behavior.

In his struggle for a new America, Lincoln Rockwell was jailed, beaten, smeared, darsed, lied about and reviled his enemies. But he never marrendered to any pressure, no matter how great. For every attack he knew only one answer: counterattack. Lincoln Rockwell fought, and he died. And yet he is not really dead, for he built a movement and spread an idea. 
Mike Steward and Douglas Niles were also arrested.

The three were charged by the U.S. Commissioner of the Eastern district with being disorderly persons on federal property, and were released on their own recognizance. Trial date was set for September 21.





# Brown Held on \$25,000 Bail

H. Rap Brown, controversial chairman act that makes it illegal to carry firearms or the Student dronviolent Coordinating Committee, was jailed under \$25,000 bail yesterday in New York on a charge of violating the Federal Firearms Act.

Brown's attorney, William M. Kunstler, termed the bail figure "outrageous" and said Brown, who faces an extradition hearing Wednesday in Richmond on Maryland charges of inciting to riot and arson, was being held a "political prisoner."

No professional bondsman was willing to Act. put up the \$25,000 needed for Brown's release, a SNCC spokesman said, even though nearly \$10,000 in cash had been raised. He said the sum usually demanded by bondsmen for \$25.000 bail is \$2500.

"BLACK POWER" BROWN JAILED ON FIREARMS CHARGE

H. Rap Brown, head of SNCC and currently facing charges of inciting a riot in Cambridge, Maryland, found himself enmeshed in further legal difficulties recently. Brown was arrested by two Internal Revenue Service agents outside of a New York apartment, following an air flight from New Orleans. The Justice Department reported that Brown had illegally transported a semi-automatic .30 calibre carbine by air from New Orleans to New York.

· A search of the apartment where Brown was arrested, revealed a cache of ammunition as well as the weapon. Brown was jailed under \$25,000 bail. His attorney, William M. Kunstler, charged that his client's imprisonment was a plot to keep him under wraps.

However, reports have been circulating that on the second day of Brown's imprisonment, an anonymous syndicate had raised \$10,000 to help secure his release.

# MACKAY man

Court officials said Wenberg was in the U.S. on a tourist visa and living at the Nazi Party headquarters near where Rockwell was shot to death.

> Rockwell, 49, was shot dead last Friday, not far from the party's national headquarters in Arlington, Virginia.

Patler, 29, was arrested the same day and charged with murder.

> WASHINGTON--President Johnson plans to ask Congress shortly to draft legislation which would give federal assistance to interracial

couples, who have become the primary victims of discrimination and the increased hostility between Whites and Negroes. The presidential move is reported as a follow-up to the recent Supreme Court decision outlawing state laws against mixed marriages.

Although the White House declined official comment, one congressional source close to the Administration declared that the President was "deeply concerned about the plight of those married couples of mixed racial background who, because of their unique situation in our society, have most keenly felt the effects of discrimination arising out of the increased hostility between White and Negro citizens". He said this discrimination was critically felt in two areas the government could remedy: housing and employment.

The President specifically intends to request assistance in the form of special rent subsidies and interestfree loans on new housing. Repayment on government loans would be reduced by 25% with the birth of each child to the mixed couple. A continued on 7

couple which had four children within a six-year period would have the entire mortgage canceled.

The Administration would also like to see a whole new series of federally-financed housing developments, which would give priority to interracial occupants. The projects would be located in 24 states in the South, Midwest, Northeast, West Coast, Alaska and Hawaii.

Also sought is legislation which would provide federal assistance in the area of employment. The President has already instructed the Commission on Government Commission on Government Contracts to submit specific recommendations to assist the wage-earners of racially-mixed households in job placement.

It was emphasized that the provisions of any new program probably would not be limited to Negro-White couples, but would very likely include couples of other mixed backgrounds, such as Orientals and Caucasians. Thousands of servicemen married to Japanese and Korean wives would probably

become eligible for benefits under any proposed legislation.

Although the White House will press for these measures to secure relief for an immediate social and human problem, it was revealed that the Administration is even more concerned with finding a long-range solution to America's growing racial problem. In meeting the crisis of the nation's mixed couples, the President hopes to find an important answer to the dilemma.

The presidential proposal is expected to encounter strong opposition, however, particularly from Southern lawmakers. Congressman John R. Rarick (D. La.) stated his position quite emphatically when told of the White House plans. "This is nothing more nor less than federally subsidized miscegenation", he declared. "If the President is calling for integration in the bedroom, then he has simply gone too far."

# N.J. chief wants 700 tan guards

TRENTON, N.J. (UPI) —
Gov. Richard J. Hughes of
N.J. announced today the
state would recruit up to 700
colored persons for the New
Jersey national guard. He
said permission for this had
been granted by the Department of the Army.
Hughes said the

Hughes said the non-whites would be accommodated in the guard by increasing its strength by up to 5 percent over present levels. He said permission for the plan was sought Aug. 14 by New Jersey Chief of Staff Maj. Gen. James F. Cantwell.

The governor indicated to a news conference that members of other minority groups such as Puerto Ricans would be included in the 700.

HUGHES ADMITTED there were complex legal questions involved in any recruitment program which would seek out minority group members and rule out whites. He said there were several thousand persons on the national guard waiting list, some of them colored. The governor referred questions about the legality of the plan to the Department of the Army in Washington. Hughes said that as far as he knew, New Jersey was the first state to take action in implementing the recent re implmenting the recent recommendations by the President's Advisory Commission on Civil Disorders that more non-whites be added to the national guard. Hughes also said the state

would launch a recruiting effort to attract more colored to the state police; which presently has only five non-whites among its 1,200 members.

NO WHITES NEED APPLY!

New Jersey's Governor Richard Hughes announced recently that he would recruit 700 more niggers for the National Guard. He said that permission for his sell-out program had been granted by the Department of the Army. Hughes also indicated that Puerto Ricans would be included in the 700 figure.

Hughes admitted that there were some complex legal problems involved because his recruiting program would deliberately discriminate against Whites in favor of non-Whites.

The Governor added that he would also launch a recruiting effort to attract more niggers into the state police.

# Last Minute

GI Sentenced As Recruiter For U.S. Nazis

FRIEDBERG, Germany, Sept. 13 (AP)—A 19-year-old U.S. soldier was sentenced today to three months in an Army stockade for disobeying an order against recruiting fellow soldiers for the American Nazi Party.

Pvt. William David Whitney of Redondo Beach, Calif., pleaded innocent to the charge before a special court martial, but the court of five officers

found him guilty.

Whitmeyer said he had done no recruiting because Party regulations forbid soldiers on active duty to do so. His commanding officer, however, said Whitmeyer continued to distribute Nazi material after being ordered not to.

Whitmeyer declared the testimony against him was marked by "personal prejudice."


